**Michael Kazin** is a professor of history at Georgetown University. His books include *A Godly Hero: The Life of William Jennings Bryan* (2006); *America Divided: The Civil War of the 1960s*, with Maurice Isserman (3rd edition, 2007); *The Populist Persuasion: An American History* (revised edition, 1998), and *Barons of Labor: The San Francisco Building Trades and Union Power in the Progressive Era* (1987). He has also edited *In Search of Progressive America* (2008) and, with Joseph A. McCartin, *Americanism: New Perspectives on the History of an Ideal* (2006). He has been awarded fellowships from the Guggenheim Foundation, the Woodrow Wilson Center, the National Endowment for the Humanities, and the Smithsonian Institution. He is working now on *American Dreamers: A History of the Left in the United States* and is editor-in-chief of *The Princeton Encyclopedia of United States Political History*, in progress. He is a regular contributor to *The Washington Post*, *The American Prospect*, *Dissent*, *The Nation*, *The New York Times Book Review*, and other publications.

**William A. Blanpied** served as Senior International Analyst at the National Science Foundation (NSF) from 1983 to 2003, except for the period from July 1999 through August 2002 when he served as Director of the NSF Tokyo Regional Office. He retired from federal service in 2003. From January 1999 to the present, he has been a principal point of contact in the United States for organizing an approximately annual series of Sino-U.S. Science Policy Dialogues, funded in part by NSF. Blanpied held faculty appointments in the physics departments at Case Western Reserve, Yale, and Harvard Universities. From 1969 to 1971, he was a member of NSF's Science Education Liaison staff in New Delhi, India. He is the author or co-author of three books, and has published numerous articles and reviews on physics, history of science, international science, and science policy.

**Franklin Noll** is president of Noll Historical Consulting, LLC. He is a historical consultant to the Bureau of Engraving and Printing (BEP), running its history program and conducting research in the history of the BEP, U.S. currency, and the public debt. He has authored numerous papers on these subjects and is considered one of the foremost historians on the history of the public debt. He holds a Ph.D. in history from the University of Maryland, College Park.

**Leah M. Wright** is a doctoral candidate in the Department of History at Princeton University. Her dissertation is entitled "The Loneliness of the Black Conservative: Black Republicans and the Grand Old Party, 1964–1980," and proposes a new understanding of the interactions between African American politics and the American conservative movement. Her research interests include 20th-century United States history, American political history, and African American history. She has conducted extensive research in a number of federal archives and collections, and has received fellowships and research grants from the Woodrow Wilson Foundation, the Lyndon Baines Johnson, Gerald Ford, and George H.W. Bush Presidential Libraries. Ms. Wright graduated from Dartmouth College with a B.A. in History in 2003.
